This contract is entered into by JMc Video and the above-named client for the purpose of securing the services of JMc Video for the wedding date given above. JMc Video agrees to provide all services for which deposit is given.

For *packages*, a **non-refundable** deposit of 25% of the total cost is due at signing. For photo montages, bride and groom, or appropriate party, will meet with Mr. McGlothlin six to eight weeks prior to the wedding date to exchange pictures and go over details of the day. An installment of 50% of the total cost is due no later than 14 days prior to the ceremony date. If payment of the installment of 50% of the total cost is not received on or before 14 days before the ceremony date, this contract shall be considered null and void, and the non-refundable deposit will be forfeited. The remaining balance (25% of total cost) is due upon delivery of the finished product. Please make checks payable to JMc Video.

For *documentary style coverage*, a **non-refundable** deposit of 50% of the total cost is due at signing. A final payment of 50% is due no later than 14 days prior to the ceremony date. If payment is not received on or before 14 days before the ceremony date, this contract shall be considered null and void, and the non-refundable deposit will be forfeited.

John McGlothlin will be the primary videographer for the wedding. In the event of an unforeseen accident or emergency, JMc Video will do their best to try to find a replacement of equal abilities. Should no one be available, all moneys paid will be refunded in full, including deposit.

JMc Video will have complete access to any event inside and outside the church/chapel, including all photo sessions, bridal party getting ready for the wedding, preparation of facilities, etc. Should JMc Video not be permitted to videotape any of the above mentioned activities, the quality of the finished video will be compromised and not be representative of the quality of the demo video on which the bride and groom based their choice of videographer.

The unedited footage (the camera originals and camera original copies) remains the property of JMc Video and will not be available for purchase. JMc Video may use reproductions or images contained in the contracted services for demonstrative uses or advertising. JMc Video will make every effort to videotape every important event on the wedding day; however circumstances may occur outside of the control of the videographer. While every reasonable effort will be made to produce and deliver outstanding video of the wedding events, JMc Video cannot guarantee delivery of any specifically requested images or audio due to the fact that weddings are uncontrolled events.

Upon signing this contract and entering into this agreement, the client accepts and approves of the professional and creative judgment made by JMc Video as to the outcome of the final produced DVD as outlined in the package description within this contract. Any additional editing requested by the client including additions, omissions, retractions, or alterations, will be subject to additional charges. All reasonable efforts will be made to produce the final DVD within three to five months following the wedding date, contingent upon the client supplying JMc Video with all necessary photos, information, payment, and other materials.

JMc Video asks that you inform your photographer that you have secured the services of a professional videographer for your wedding. JMc Video will make every effort to work side-by-side with your photographer and demonstrate professional courtesy and respect for the job they were hired to do, and request that the photographer demonstrate the same professional courtesy. JMc Video has no control over the photographer's mobility during the ceremony and reception, and it is sometimes unavoidable for them to be captured on video during the ceremony or reception.

LIMITATION OF LIABILITY: The Client agrees to hold harmless JMc Video or its associates for any faults in tapes and/or footage caused by the actions of other persons, reception halls, photographers/videographers (professional or otherwise), manufacturers or any circumstances beyond their control (weather, power failure, etc.), missing images through equipment malfunction or by any other means beyond the control of the videographer, or any physical damage to property or persons by the contractor or equipment while in the process of carrying out contracted services.

TRAVEL EXPENSES: Any travel expenses required for distances over 50 miles, including meals and overnight accommodation expenses if applicable, will be the responsibility of the client and will be included in the final balance due.

Description of Services

Documentary-style coverage - This is a basic coverage option for couples who wish to document the ceremony and some of the activities surrounding it. This option includes the professional videography services of one videographer for 4 hours beginning one hour prior to the start of the ceremony, minimal editing, and 2 authored DVDs. Ceremony coverage includes one camera operated by the videographer and one unmanned camera. The cost of this basic service is \$995 for weddings in Tarrant County on weekdays or weekends in the off-peak season (January through March and September through November).

Pre-ceremony coverage - Video coverage of the bridal party at the ceremony location before the wedding. This often includes touching and funny moments between family members and friends. The edited footage will be included in the *highlights montage* or the *prelude montage*.

Ceremony coverage - Usually includes one operator videotaping the wedding party from behind the officiator, one operator moving about during the ceremony, and may include another operator videotaping from the back of the venue. Placement and movement of cameras during the ceremony may be restricted by policies of the location or wishes of the bride and groom. The final product will include the edited footage of the complete ceremony.

Highlights montage - Important moments of the day are edited and set to instrumental music.

Reception coverage - One or two operators videotape reception events and guest interactions. Quality of coverage may be dependent on lighting conditions at reception venue. A small on-camera light may be necessary to ensure adequate coverage. The final product will include edited highlights from the reception.

Authored DVDs - All the elements of your package are delivered on a fully-authored DVD with navigational menus.

Rehearsal attendance - The principal videographer will attend the rehearsal to ensure the best possible coverage of the ceremony. Video coverage of the rehearsal is available at extra cost.

Prelude montage - A selection of video segments documenting the pre-ceremony events.

Bridal pre-location - Coverage of an additional pre-ceremony location such as hair and makeup appointment or bride's home. The edited footage will be included in the *prelude montage*.

Internet highlights - Highlight and montage video segments published on our website for one year.

Love Story - Edited video interview with the bride and groom detailing their meeting, dating, and engagement.

Growing Up montage - A collection of still photos of the bride and groom set to music.

Bridal shower coverage - One camera for two hours at one location. The final product includes highlights from the shower.

Honeymoon photos montage - A collection of still photos from the honeymoon set to music.

Rehearsal and dinner coverage - One camera coverage of the wedding rehearsal and rehearsal dinner. The final product will include edited highlights from the rehearsal and dinner.
